PRESIDENT REPORT

There were thirty-one new classified employees going to new hire orientation! The Personnel Commission's Reclassification Review Salary Study and Recommendations were once again pulled from the school board agenda. Special Education Advisory Committee (SEAC) is still meeting with the goal of finding the least restrictive environment for our students with special needs. Courtney and Nancy Brundrett will be facilitating a Professional Growth Day offering on September 28th. The class will focus on Special Education Support.

VICE PRESIDENT REPORT

Kim gave an overview on the PUSD Strategic Safety Planning Committee meeting that she attended on September 11, at the district office. It was well attended. It began with a PowerPoint and a panel discussion which included Detective Jess Allensworth, Sgt. Wes Albers, Sheila Hatfield, Fran Hjalmarson, Greg Mizel, and T.J. Zane. The panel discussion lasted for over an hour. At this time, we discussed the current districtwide safety initiatives that include the following:

GENERAL COUNSEL REPORT

Vacation Accrual ULP – This case involves the District's unilateral changes to vacation accruals at the beginning of the 2016-2017 school year. PERB has issued a Complaint against the District and the parties have agreed to pursue professional mediation of this dispute prior to going to trial and have agreed on the mediator. The mediation is scheduled for early October.

MEMBER AT LARGE

Nancy Brundrett has heard that certain school sites are tracking CPR certification cards. Unless it is a job requirement, sites cannot force you to take a CPR class. COMMITTEE UPDATES

Health and Welfare:

We are anticipating a signed MOU in early October to offset the upcoming increases in Health and Welfare. The district is planning to launch "Benefits Bridge" which essentially means that open enrollment will be done online in place of the big packets we have received in years prior. There will be computer lab sessions scheduled at various sites for those who may need

assistance with online open enrollment. Other than the addition of Benefits Bridge, there will be no major changes to health and welfare offerings in 2019. PSEA will be working with the District to explore potential health care changes for consideration in 2020. PSEA will conduct a survey to get a sense of what matters most to the membership. The survey will be conducted after open enrollment has ended and it is crucial that we all participate.
