- **DBAC Direct Dealing ULP** This case involves the District illegally bypassing PSEA by discussing negotiable items with PSEA-represented employees in the "District Budget Advisory Committee". PSEA filed a PERB charge on February 8, 2018 and we are awaiting a decision by PERB on whether to issue a complaint.
- Vacation Accrual ULP This case involves the District's unilateral changes to vacation
 accruals at the beginning of the 2016-2017 school year. PERB has issued a Complaint
 against the District and the parties have agreed to pursue professional mediation of this
 dispute prior to going to trial and have agreed on what mediator to contract.
