GENERAL COUNSEL'S REPORT (Ricardo Ochoa)

Employee Issues

- Dress Code II ULP Last summer, Business Support Services announced to employees in the
 Finance Department a new "summer dress code" and announcing that the prior "dress code"
 would resume in August. PSEA objected that the District did not negotiate any such dress
 code, and asked the District to rescind the memo and clarify that there is no such dress code.
 The District failed to meaningfully rescind the dress code, and PSEA has now filed a PERB
 charge over the District's unilateral adoption of a dress code. This is the second PERB charge
 that PSEA has been forced to file in the last four (4) years over the District unilaterally adopting
 a dress code for PSEA-represented employees.
- Vacation Accrual ULP PSEA and the District have reached a proposed settlement agreement
 of this PERB charge. The District's Governing Board will vote tomorrow (January 17) on
 whether to approve the settlement. If approved, the District will pay all contracted Unit I
 employees a one-time payment equal to one two days' of pay (roughly between 0.5% and 1%
 of salary), depending on the length of an individual's contracted work year.

PERB Charges

Dress Code Charge: 30 day pause, waiting on District response.

TREASURER REPORT

- Audit: There are different levels of audit review needed by businesses. It depends on whether spending is mostly germane or not germane. Per our newly ratified By Laws, PSEA changed from a Fall Audit, to a Yearly Review to save on cost since the Hudson notice is no longer necessary.
