GENERAL COUNSEL'S REPORT (Ricardo Ochoa)

Employee Issues

- Dress Code II ULP Last summer, Business Support Services announced to employees in the Finance Department a new "summer dress code" and announcing that the prior "dress code" would resume in August. PSEA objected that the District did not negotiate any such dress code, and asked the District to rescind the memo and clarify that there is no such dress code. The District failed to meaningfully rescind the dress code, and PSEA has now filed a PERB charge over the District's unilateral adoption of a dress code. This is the second PERB charge that PSEA has been forced to file in the last four (4) years over the District unilaterally adopting a dress code for PSEA-represented employees.
- Vacation Payout PSEA and the District have reached a proposed settlement agreement of this PERB charge. The District's Governing Board voted on January 17 to approve all contracted Unit I employees a one-time payment equal to one two days' of pay (roughly between 0.5% and 1% of salary), depending on the length of an individual's contracted work year.
